Today is an important day. We are exactly six months away from the deadline for hundreds, if not thousands of families to register claims for their loved ones who died of WTC-related illnesses. That means we have just six months to spread the word to these 9/11 families who have not yet registered, before their time to register runs out.

The Victim Compensation Fund (VCF) requires death claims to be registered within 2 years of a responder or non-responder's passing. So many families missed the deadline either because they didn't realize that they were eligible or because they were previously told that they were too late to register. In an incredible act of compassion, the VCF's Special Master extended the deadline for widows, widowers and families who missed the strict time limit to register.

The deadline to register older death claims has been extended until July 29, 2021.

While the VCF has been permanently extended, after July 29th any family who does not register the claim within two years of their loved one's death will be ineligible for compensation. Since more than 1/3 of the families who have retained our firm in the past year did so more than two years after losing their loved one, we know that there are many other families who still don't realize that they are entitled to an award which could provide them with financial security.

Please help us spread the word about this impending deadline to anyone who you think should take advantage of this last chance to register. Let's use every minute of these next six months to help as many families as possible.

We received the attached information from GHI in response to your complaint. As GHI indicates, network adequacy standards only apply to the insurer's in-state service area. There are no laws applicable to networks outside of the state.

in addition, this Department does not have the ability to require GHI to increase the rate it pays to providers, whether in-network or out-of-network.

This letter responds to the inquiry that you submitted on behalf of the above complainant, which was received on 07/27/2020. Mr. and Mrs. complained about several issues which includes their concerns that EmblemHealth has a limited participating network outside of the tri-area, and our website does not display accurate information about a provider participating status.

Mr. and Mrs. are enrolled in an EmblemHealth PPO Plan through the City of New York effective 10/01/1983. Medical benefits are provided to employees and retirees of the City of New York under the City of New York Comprehensive Benefits Plan (CBP) Program.

The CBP is one of approximately 11 health plans sponsored by the City of New York (the "City") from which City employees and retirees can choose to enroll themselves and their eligible family members. The CBP is a preferred provider organization (PPO) plan that covers services of in-network providers and also enables members to select out-of-network providers and to submit a claim to GHI for reimbursement at the rates set forth under the applicable reimbursement schedule, which is unique to the CBP.

The CBP is paid for entirely by the City, and members pay no out-of-pocket premiums, unless, the member purchases the Optional Rider. The terms of the CBP have been heavily negotiated between GHI, the City, and the group of Municipal Unions (the "Unions") that represent City employees and retirees. The City bears the cost of CBP employees and retirees.

Although GHI has an extensive number of in-network providers that accept the CBP, the vast majority of those providers are located within the tri-state region. The City and the Unions are well aware of the geographic scope of the network for which they contracted under the CBP. Members are told that GHI's reimbursement for out-of-network services represents less than the cost of the service and is based on 1983 procedure rates that have not increased since that time.

Initially, please be aware that GHI is licensed to conduct the business of insurance in New York State only and New York State is GHI's service area. While GHI does strive to have network providers available to members outside of New York State, and in particularly in states neighboring New York, such out of state provider availability is not subject to network adequacy standards and is provided solely for the convenience of our members.

Notwithstanding the foregoing, part of EmblemHealth's mission is to provide members access to some of the most qualified and respected providers in the area in which they reside. Our Provider Network Management department is consistently reviewing the access to providers for members residing outside of New York State.

In the spirit of accessibility, EmblemHealth updates it's on line provider directory via the website daily. However, the provider directory may contain names and telephone numbers of providers who no longer participate in our network or who have stopped practicing. Providers are advised to contact EmblemHealth if their circumstances or information changes. We suggest that the member also contact our Customer Service Department directly to confirm their participation.

Please be advised that members have always had the opportunity to submit names of local providers to EmblemHealth's Professional Relations division requesting that an information packet be sent to the provider as to how to apply to become an EmblemHealth participating provider. Members may also speak to their local providers and request that they apply to become a participating provider. Providers interested in participation may apply through EmblemHealth's website. Providers should access the website (www.EmblemHealth.com), select "Provider", then select "Join our Network" and follow the directions on how to join EmblemHealth's Network. In addition, members can submit their request to the provider to participate or to Customer Service, who will send the request to our Provider Relation Management Department to reach out and recruit the provider. At this time, however, please note that our out of state network is closed.

Under CBP, Mr. and Mrs. have the option to see out-of-network providers and to submit a claim to GHI for reimbursement at the rates set forth under the applicable reimbursement schedule.

IRS WARNS OF INCOME TAX SCAMS

As tax season approaches, the Internal Revenue Service reminds taxpayers to be on the lookout for an array of tax scams related to identity theft and refund fraud. Every tax season, there is an increase in schemes that target innocent taxpayers by email, phone, and online.

Some of the most prevalent IRS impersonation scams:

Requesting fake tax payments: The IRS has seen automated calls where scammers leave urgent callback requests telling taxpayers to call back to settle their "tax bill." These fake calls generally claim to be the last warning before legal action is taken. Taxpayers may also receive live calls from IRS impersonators. They may demand payments on prepaid debit cards, iTunes and other gift cards or wire transfer. The IRS reminds taxpayers that any request to settle a tax bill using any of these payment methods is a clear indication of a scam. (IR-2016-99)

Targeting students and parents and demanding payment for a fake "Federal Student Tax": Telephone scammers are targeting students and parents demanding payments for fictitious taxes, such as the "Federal Student Tax." If the person does not comply, the scammer becomes aggressive and threatens to report the student to the police to be arrested. (IR-2016-107)

Sending a fraudulent IRS bill for tax year 2015 related to the Affordable Care Act: The IRS has received numerous reports around the country of scammers sending a fraudulent version of CP2000 notices for tax year 2015. Generally, the scam involves an email or letter that includes the fake CP2000. The fraudulent notice includes a payment request that taxpayers mail a check made out to "I.R.S." to the "Austin Processing Center" at a Post Office Box address. (IR-2016-123)

Soliciting W-2 information from payroll and human resources professionals: Payroll and human resources professionals should be aware of phishing email schemes that pretend to be from company executives and request personal information on employees. The email contains the actual name of the company chief executive officer. In this scam, the "CEO" sends an email to a company payroll office employee and requests a list of employees and financial and personal information including Social Security numbers (SSN). (IR-2016-34)

Imitating software providers to trick tax professionals: Tax professionals may receive emails pretending to be from tax software companies. The email scheme requests the recipient download and install an important software update via a link included in the e-mail. Upon completion, tax professionals believe they have downloaded a software update when in fact they have loaded a program designed to track the tax professional's key strokes, which is a common

tactic used by cyber thieves to steal login information, passwords and other sensitive data. (IR-2016-103)

"Verifying" tax return information over the phone: Scam artists call saying they have your tax return, and they just need to verify a few details to process your return. The scam tries to get you to give up personal information such as a SSN or personal financial information, including bank numbers or credit cards. (IR-2016-40)

Pretending to be from the tax preparation industry: The emails are designed to trick taxpayers into thinking these are official communications from the IRS or others in the tax industry, including tax software companies. The phishing schemes ask taxpayers about a wide range of topics. E-mails or text messages can seek information related to refunds, filing status, confirming personal information, ordering transcripts and verifying PIN information. (IR-2016-28)

If you receive an unexpected call, unsolicited email, letter or text message from someone claiming to be from the IRS, here are some of the tell-tale signs to help protect yourself.

The IRS Will Never:

- Call to demand immediate payment using a specific payment method such as a prepaid debit card, gift card
 or wire transfer or initiate contact by e-mail or text message. Generally, the IRS will first mail you a bill if
 you owe any taxes.
- Threaten to immediately bring in local police or other law-enforcement groups to have you arrested for not paying.
- Demand that you pay taxes without giving you the opportunity to question or appeal the amount they say you owe.
- Ask for credit or debit card numbers over the phone.

If you get a suspicious phone call from someone claiming to be from the IRS and asking for money you should:

- Do not give out any information. Hang up immediately.
- Search the web for telephone numbers scammers leave in your voicemail asking you to call back. Some of the phone numbers may be published online and linked to criminal activity.
- Contact TIGTA to report the call. Use their "IRS Impersonation Scam Reporting" web page or call 800-366-4484.
- Report it to the Federal Trade Commission. Use the "FTC Complaint Assistant" on FTC.gov. Please add
 "IRS Telephone Scam" in the notes.
- If you think you might owe taxes, call the IRS directly at 800-829-1040.

Warning Signs

- o You receive collection calls or bills for products you or your family did not receive.
- You are denied credit.
- You or a member of your family is denied government benefits because the benefits are being paid to another account using your or your family member's SSN.
- You are notified by the Internal Revenue Service that more than one tax return using your SSN has been filed within one year.
- You owe additional tax, refund offset, or had collection actions taken against you for a year you did not file a tax return.

IRS doesn't tell 1 million taxpayers that illegal immigrants stole their Social Security numbers

The IRS has discovered more than 1 million Americans whose Social Security numbers were stolen by illegal immigrants, but officials never bothered to tell the taxpayers themselves, the agency's inspector general said in a report.

If you receive an unsolicited email that appears to be from either the IRS or an organization closely linked to the IRS, such as the Electronic Federal Tax Payment System (EFTPS), report it by sending it to phishing@irs.gov.

2019 Medicare Part B Reimbursement Differential Request Form

The City of New York Health Benefits Program reimburses eligible retirees and their eligible dependents for their standard Medicare Part B premiums. Please note that the 2019 Medicare Part B reimbursement was issued in April 2020.

DO NOT COMPLETE THIS FORM:

- If your Medicare enrollment effective date was during calendar year 2016 or later (because you already received the monthly maximum standard reimbursement of \$135.50).
- If you have applied, or intend to apply, for IRMAA reimbursement for 2019. (The additional differential payment will be issued to you automatically separate from your IRMAA payment in October 2020.)

Please note: Penalties relating to late Medicare Part B enrollment are not reimbursed.

If your 2019 monthly Medicare Part B premium was between \$110.00 and \$135.50 because:

Instructions For Continuing Health Coverage To Widows

Effective November 13, 2001, New York State law provided surviving spouses of retired uniformed members of the New York City Police and Fire Departments the ability to continue their health benefits coverage for life. Such coverage will be at a premium of 102% of the group rate and must be elected within one (1) year of the date of the death of the member. Contact the Health Benefits Program, in writing, enclose a copy of the members' death certificate and you will receive a Continuation of Coverage-Chapter 436 Application. The application needs to be completed and signed by the spouse or the registered domestic partner of the deceased member.

Once the Application is complete it must be mailed to the health plan that <u>you select</u> which in most cases is what you had before the death. However, you may select a different plan.

The coverage will be retroactive to the date of the retiree's death and the selected health plan will bill the widow directly. The City will no longer be involved in health coverage nor will there be a Medicare rebate check after the date of the retiree's death, if the widow was also on Social Security, paying for Medicare premiums, unless under the following circumstances:

Some years ago, due to the large number of NYC active Police and Fire Officers who died at the World Trade Center the City enacted legislation for surviving spouses (includes registered domestic partners) that granted them Health coverage and Health and Welfare Benefits. The Health coverage provided by the City and the Health and Welfare Benefits by the Unions. This then added coverage such as eyeglasses, dental, prescriptions, etc., to those new and existing widows.

What we find is that some of the "Heart Case" widows are not aware of the aforementioned provisions. The Pension Section has determined in order for them to qualify, regardless of the cause of death, is that he would have survived if he had a healthy heart. In order for the widow to qualify all that needs to be done is to obtain a letter from his Cardiologist that the deceased was under treatment for the heart condition submitted to them. Once accepted by the City Health Benefits Section the widow must reregister with them, by contacting them, indicating her Social Security Number and then is included in the Medicare Part "B" reimbursement program.

DO NOT USE THE FORM ON THE OFFICE of LABOR RELATIONS WEBSITE AS THIS BENEFIT WAS LEGISLATIVELY GRANTED ONLY TO NEW YORK CITY POLICE AND FIRE WIDOWS.

The "City" will also owe the surviving beneficiary \$1,000 for each full month of the calendar year the retiree lived prior to his or her death from the Variable Supplement Fund if they were receiving the benefit. This benefit is normally paid at the end of each calendar year, usually December 15th. This is usually paid out to the beneficiary shortly after all of the required paperwork is processed as well as the insurance policies.

NOTE: If you were also receiving Social Security benefits and paying Medicare premiums - those payments prior to the retirees death are payable to you and also the retiree's paid premiums as the beneficiary if the retiree had you properly listed as such. However, be aware those are always in the next calendar year. Please see the relevant "FORMS" in this website.

PARAMETERS TO RENEW

RETIRED ID CARDS AND VIA PROXY

- Retired Identification Card must be previously expired or expiring within 3 months
 of expiration date.
- Retiree must have identification card photo on file between November, 2002 and the present
- 3. Prior to November, 2002 member must appear in person for a new photo.
- 4. Retired member of the service or proxy must present the expired retired identification card for renewal.
- If retired identification card is lost, member or proxy must bring a copy of the jurisdiction's incident report or official police report.
- 6. "Retiree Application" form must be completed in advance or in the alternative when present.
- Retirees that reside within New York City and adjoining counties must renew their identification card personally.
- 8. Retirees that reside outside New York City and the adjoining counties may have a proxy renew their identification card.
- If proxy is renewing more than 10 identification cards, they may be required to return later that day or the next day to accommodate processing.

These parameters may be subject to change without notification.


