VI. **NEW BUSINESS:**

- A. Len Salerno our Health & Welfare Officer brought forth the following information at the meeting:

Medicare Advantage for Over 65 and Disabled:

In an effort to implement cost savings measures, NYC is reviewing bids from Medicare Advantage providers. What this means is the Medicare will continue being primary insurance, but Emblem Health GHI will no longer provide supplemental coverage. Supplemental coverage will be provided by the group sponsored Medicare Advantage plan. If your doctors accepts Medicare, he/she will HAVE to accept the Medicare Advantage plan. Supposedly, there will be no reduction in benefits, such as transportation assistance to appointments, meals after in-patient stays, fitness program and nurse support. This is supposed to take effect 7/1/2021 but we will see.

For those NOT on Medicare:

Emblem Heath GHI had closed panels to out of state doctors. After a letter writing campaign and with the invaluable help of Bill McMahon (Retired Sgt.) and certain key members of the PBA, DEA, and SBA, Emblem was forced to re-open the panels. Since mid March, at least 64 new doctors have been added to the panel (we don't know what specialties or where). In addition, Emblem is being audited because their website is misleading and inaccurate. It seems as if they are finally being held to task.

B Tony Marone read the following **Resolution in Condemnation of the Appointment of a Felon** who killed a police officer to a committee who makes recommendations for the reform of the Ithaca NY Police Department:

Whereas, Governor Cuomo, the Governor of the State of New York, did issue Executive order number 203, which required that local governments within the State that operate police agencies, to review their public safety policies and prepare a report on their plans to address the needs of the communities served by such police agencies and to ensure that fairness and legitimacy in addressing racial bias and disproportionate policing of communities of color, with a directive to respond to the Governor by April 1st, 2021. **And whereas**, in response to the Governor's order, the Mayor of the City of Ithaca in Union with the Executive Officer of Tomkins County, both of New York State, did form a committee to accomplish the mandates of the Governor's order. **And Whereas**, the Mayor of Ithaca, et al, unconstrained by the Governor of NY, did appoint one, Richard Rivera, male Hispanic, a felon and parolee, convicted of the brutal murder, execution style, of Police Officer Robert Walsh of the Police Department of the City of New York, during the commission of an attempted robbery at a bar and grill in Queens county, New York, on January 12th, 1981. **And whereas** the family of the slain officer did publicly express their complete shock and anguish that the man who murdered their father could be trusted to create police reform. **And whereas** the members of the Manasota 10-13 Club, agree with the sentiments expressed by the members of Police Officer Walsh's family and further, we protest the vile way in which this appointment disrespects and dishonors, not only the memory of Police Officer Walsh, but is an absolute insult to all our honored dead who gave their lives for the protection of the people they served in New York, throughout America and, indeed, throughout the civilized world.

Now, therefore be it Resolved that we, the members of the Manasota 10-13 Club assembled at the regularly scheduled monthly meeting of the Club on the 11th day of May in the Year of Our Lord, 2021, do utterly condemn not only those who made this unwanted, unwise, and unwarranted appointment, but we also strongly express our complete disapproval of the Governor's failure to monitor the members appointed to the committee and his failure to place any constraints on those responsible for making the appointment. **And be it further Resolved** that we, the members of the aforesaid club, do

reject the counterfeit expressions of remorse by the perpetrator, or any excusal of his behavior based on his youthful age of sixteen years at the time of occurrence of the murder of Police Officer Walsh.

The aforementioned Resolution was mailed to both NYS Governor Cuomo and Ithaca Mayor Myrick

Citing Crime Spike, Shea Calls For Increase in NYPD Budget

Stanching the bloodshed of an increasingly violent year requires a reinvestment in the NYPD, Commissioner Dermot Shea argued during an occasionally contentious City Council committee hearing on the agency's Fiscal Year 2022 budget last week.

Lamenting that the department's upcoming spending plan will be about the same as it was for FY 2021, Mr. Shea in his opening remarks said the Council needed to consider the effect on public safety of a stagnant policing budget. "When tools are taken away, there are real-world consequences on the streets in the form of increased crime and victimization," he said, and characterized next year's fiscal year budget as already "underfunded."

OT Cut 'Significant'

Noting in particular the near-doubling of shooting incidents so far this year compared to last—resulting in a 20-year high—he said that while the department has a responsibility to spend prudently, lawmakers must ensure police are sufficiently funded to do the jobs they are given. Law enforcement and legislators at the local, state and Federal levels "need to do much, much more to stem the violence," he said during a May 11 joint hearing of the Council's Finance and Public Safety Committees.

Much of the discussion, as well as some pointed disagreements, focused on the NYPD's spending for overtime. Although the department has already exceeded its FY2021 overtime allocation six weeks before the fiscal year concludes, the NYPD's Deputy Commissioner of Management and Budget, Kristine Ryan, noted that this line item was 30 percent lower than for FY2020. She attributed increased overtime spending to a trimmed officer headcount and the rise in crime.

"We all know that every agency has to contribute, but the size of the cut, at 60 percent of our overtime budget, was really quite significant, and as the landscape has evolved over the year, we really had to focus on the critical areas," she said. "So, as conditions have evolved on the ground, we have had to continue to utilize overtime resources, and that budget cut brought us to a historic low. We haven't seen a level that low in at least 15 years."

According to the Mayor's Executive Budget, the NYPD's budget will increase by \$52 million, or just under 1 percent, to \$5.43 billion. That figure, however, is

just a forecast. For instance, the NYPD's modified FY2021 budget grew \$159 million, a 3-percent increase from the executive budget. It could climb higher still, given the rate of overtime spending so far.

'A Critical Tool'

Mr. Shea said an increased overtime budget was imperative if the department was to get a better handle on crime. "Overtime is a critical tool in maintaining public safety," including in the subways and public housing, he said. "The bottom line is less overtime equals less cops doing police work. It is that simple."

While the NYPD graduated two classes earlier this month, those were the first in a year, and while deploying another 847 Officers onto city streets will help, Mr. Shea it won't make up for the aggregate loss of 1,200 cops last year as well as a reduction of "significant overtime" that the department for well over a decade has relied on to supplement personnel in places that experience upticks in violence.

He noted that the city's manifold cultural events, such as the Puerto Rican Day Parade and the West Indian Day Parade, had been cancelled because of the pandemic, thereby decreasing the need for overtime. And as those events return to the calendar, the department will need greater flexibility to assign overtime. Although the city "will roar back in time," Mr. Shea cautioned that "the foundation of public safety" on which the city depends must be solid, he said. The Commissioner, however, did not note that the department had nevertheless contended with massive protests and demonstrations citywide.

'A Major Disconnect'

But the Finance Committee Chair, Daniel Dromm, reminded Mr. Shea as much, although he did so by veering away from purely financial considerations and into policing practice. He termed the NYPD's response to the demonstrations "a disaster," and suggested that, contrary to Mr. Shea's assertions, the city might be over-policed.

"I think there's a major disconnect here," he said. "And when you talk about safety, I think you have to have the public's attitude and mindset as well. I don't feel safe oftentimes around police officers because of what I see."

He pointed out that the department had already exceeded its \$272-million FY2021 overtime budget by \$75 million, a figure that could exceed \$100 million by the time the fiscal year concludes June 30.

Mr. Dromm and Mr. Shea then sparred over the Councilman's characterization

of the police response during the protests, a skirmish that concluded with the Finance Committee chair reminding Mr. Shea that he was under oath. The Commissioner tried to placate the Councilman, but they soon engaged again. "Why should we believe that you'll stick to your overtime budget this time around? You have not given me a clear answer," Mr. Dromm asked. The two then briefly talked over each other before Mr. Dromm again pulled rank: "We're questioning you, and we are in charge of oversight of you and your budget."

Shea: Let's Be Honest

Mr. Shea deferred for a moment, but then lambasted Mr. Dromm for a perceived lack of respect after the Queens Councilman accused the Commissioner of not doing his job by "blowing" his overtime budget. "If my officers spoke to the public this way, I would fire them," he said. "Let's have an honest conversation and a back and forth where we accomplish something rather than what you're trying to do. The people of New York City deserve better."

The Councilman then accused the Commissioner of being deceitful, and upbraided Mr. Shea for repeatedly making the connection, which some data has questioned, between liberalized bail laws and the rise in crime.

"It seems to me you're scapegoating things," Mr. Dromm said.

This is the second time in five months that the Councilman has engaged in a heated, public back-and-forth with a city official. In mid-December, he clashed with the president of the Correction Officers' union, Benny Boscio, calling him "a thug" during a Criminal Justice Committee hearing on legislation sponsored by the Councilman that would curtail the use of inmate isolation in city jails.

SURVIVING SPOUSE INSTRUCTIONS

THE FOLLOWING INFORMATION IS BEING PROVIDED FOR THE BENEFIT OF SURVIVING SPOUSES. IT HAS BEEN EXCERPTED FROM VARIOUS ARTICLES DISSEMINATED BY OUR C.E.O. GENE LOEWY, IN THE PAST, BASED ON FREQUENTLY ASKED QUESTIONS AT MANY 10-13 MEETINGS OF VARIOUS CLUBS.

QUESTION: When a member passes away, what will happen to his/her spouse as far as medical coverage?

ANSWER: If the retiree has retired on 3/4 and dies from the condition that mandated the retirement, (Heart Bill, etc.) the City will continue the same medical coverage that was in effect with the retiree. This will also include Health & Welfare Benefits (dental, eyeglass & prescription drugs). If the retiree has retired for regular service or ordinary disability, the spouse will be able to continue the medical coverage but must pay for it at the group rate. The group rate is a bargain and is calculated at the cost of 102 percent of the amount that the City was paying. Due to special legislation that we were able to achieve several years ago this coverage does not expire after 36 months. This applies only to New York City Police and Fire Retirees. Upon learning of the death of a police retiree the Retiree Benefits Section of the Office of Labor Relations sends the SPOUSE an application which is referred to as "Cobra for Life." The surviving spouse fills it out and sends it to the medical plan of choice and is thereafter billed and covered by that health carrier. The survivor also can continue the Health and Welfare coverage with the respective union, PBA, DEA, SBA, SOC, (based on retirement rank) only for a period of 36 months but they must pay for that continuing benefit for a 36 month period. The Health and Welfare coverage is no longer available after the 36 months but it does not affect the Medical Coverage which is for life. However, if they are of Medicare age, we recommend they take the health plans (GHI etc.) prescription drug rider instead, and they will be partially subsidized by Medicare. But only if they can forego dental and optical benefits.

QUESTION: What happens when the 36 months expire?

ANSWER: If the spouse is not yet of Medicare age, then they should contact their medical plan provider and inquire about paying for the prescription drug rider. They can also shop for other prescription drug plans. ANOTHER OPTION FOR THE MEDICARE ELIGIBLES AT THIS TIME, IF THEY CHOSE THE COVERAGE WITH THEIR SPOUSES RESPECTIVE UNION IT IS RECOMMENDED THAT YOU GO TO YOUR LOCAL PHARMACY WITH A LIST OF YOUR MEDICATIONS AND THEY CAN RECOMMEND WHICH AVAILABLE PLAN IS BEST FOR YOU.

QUESTION: I am receiving the Medicare rebate for myself and also my spouse. When I die will my spouse continue to receive the rebate?

ANSWER: The survivor continues to be in the rebate program only if the CITY is paying the health coverage. If the CITY is not paying for the health plan then there is no justification for the CITY to provide a rebate.

NOTE: It is important to remember that the City will take the widowed spouse off the record for Medicare premium reimbursement. However, you are still entitled to all of the retroactive payments for both you and your spouse up until his/her date of death. Since this payment is always a calendar year behind, it is incumbent upon the surviving spouse to ensure this payment is received. Contact the Employees Benefits Section 212- 513 - 0470.

THE FOLLOWING IS A GENERAL GUIDE FOR THE WIDOW / WIDOWER REGARDING NOTIFICATIONS THAT MUST BE MADE BY THE SURVIVING SPOUSE AND INFORMATION YOU SHOULD HAVE ON HAND WHEN A RETIREE DIES: For Members appointed after June 30, 1940 and for members who merged from Transit/Housing as of May 1995- Notify NYC Police Pension Fund either in writing or by telephone at 233 Broadway, 25th Floor, New York, NY 10279—Attention: Retiree Death Benefits Unit, Telephone (212) 693-5607/5919.

For Members appointed prior to July 1, 1940 contact the NYCPD at 1 Police Plaza, New York, NY 10038, Telephone 646-610-8073/74 the Audits and Accounts Section, Article 1

You will need to provide the deceased first, middle and last name, the date of death, social security number, next of kin as well as the executor/of the estate and his/her address and phone number. You may also be required to provide, to complete certain records, the following: a copy of the will, a copy of the paid funeral bill, the original or certified copy of the death certificate and a certified copy of your marriage certificate and the surviving spouses social security number.

BE CERTAIN TO KEEP BENEFICIARY INFORMATION CURRENT AS MEMBERS MAY HAVE CHANGES IN SOCIAL CONDITION (MARRIED, SEPARATED, DIVORCED, ETC.) WITH BOTH THE PENSION SECTION AND YOUR UNION. ALSO NOTIFY SAME OF ADDRESS CHANGES , AS WELL AS NYC HEALTH BENEFITS SECTION, AS SOON AS POSSIBLE. THE FOLLOWING INFORMATION WAS TAKEN FROM OUR NY 10-13 ASSOCIATION OF AMERICA WEBSITE.

PREPARATIONS BEFOREHAND

Get organized now. When someone dies, one of the big problems for beneficiaries is locating the things necessary to settle the estate. Make sure you know before the death occurs where to find the following documents and information...

Will

Living Will

Trusts

Deeds (if any)

Safe-deposit boxes (location of boxes, contents and keys)

Life insurance policies

Funeral and burial instructions

Names and addresses of creditors and debtors

List of assets and where they are located

List of all advisers—attorney, accountant, insurance agent, stockbroker, etc.

Detectives - Detectives Endowment Association (D.E.A.) (212) 587-1000

HEALTH INSURANCE: C.O.B.R.A. Consolidated Omnibus Budget Reconciliation Act of 1985. COBRA has a safety net. If spouse or dependent was covered under deceased's health plan they may continue coverage under COBRA for up to 36 months. New York State in 2001 amended the Administrative Code to continue Health Care Coverage for Surviving Spouses for Life. This enables the deceased's spouse and/or dependents to receive coverage at the group rate. The City and the Line Organization health benefits stop at the death of the member. The rate, though high, is cheaper than the non group rate. NYC Employee Benefits 1-(212) 513-0470.

Contact the NYPD Operations Unit located at One Police Plaza, telephone # (646) 610-5580, for pall bearers (all five boroughs, all of Long Island and Upstate New York but not beyond Dutchess County).

Social Security: 1-800 772-1213 (Funeral Director will usually do this for you)
Fraternal Organizations to arrange for visitors, Color Guard and possible insurance benefits.

If a veteran, Notify the Veterans Administration 1-800 827-1000, (Usually Funeral Director will do this for you also Church or Temple for announcements and to arrange for funeral).

DISCHARGE PAPERS: DD 214 - Original needed for BURIAL IN NATIONAL CEMETARY, Grave marker, Funeral Allowance, Flag or Social Security, if spouse was not already receiving benefits. Service time counts toward qualification. They will photostat 1 for Veterans Administration & Social Security. if a veteran. and can't find discharge or DD 214, Need date of Enlistment, date of Discharge, Branch & Serial Number. if deceased had 100% disability for 10 years spouse is entitled to an additional benefit. (See Funeral Director for assistance)

PAID FUNERAL BILLS: 1 for Pension Bureau, 1 for Probate Court, 1 for I.R.S. if taxable estate.

THINGS YOU WILL NEED

DEATH CERTIFICATES: Death Certificates are necessary in every step to the successful administration of a decedent's estate. (Usually Funeral Director will obtain certificates as part of his service at current cost).

Pension Bureau

Veterans Administration (if a veteran)

Motor Vehicle Bureau (if auto was in deceased's name ONLY). 1 for each insurance policy

Probate Court (If probate is needed)

Your State Department of Revenue to obtain non-tax certificate (if real property is involved).

Bank accounts held in Trust for another (1 for each account if property held in a Trust)

Personal Records

Note: If estate is probated, some of the above will take a Letter Testamentary instead of a Death Certificate.

MARRIAGE CERTIFICATES WITH OFFICIAL RAISED SEAL:

Social Security, (not necessary if surviving spouse already receiving benefits)

Veterans Administration (if a veteran).

LETTERS TESTAMENTARY OR LETTERS OF ADMINISTRATION:

Motor Vehicle Bureau if auto is in the deceased's name ONLY.

One for each bank account, brokerage house account, share of stock or bonds, etc. that were in the deceased's name alone.

THINGS THAT MAY APPLY

Cancel the lease. If your parent or loved one rented a home, cancel the lease after clearing out the furnishings.

Inform insurance companies. File life insurance claims for any policies on the person's life, and request that the insurers send you Form 712, Life Insurance Statement (a statement about the life insurance that must be filed with the estate tax return).

Make sure the car insurance company continues to cover the person's car until it's sold or transferred to a beneficiary.

Make sure the homeowners policy continues to provide adequate coverage for the person's things until removed from the home.

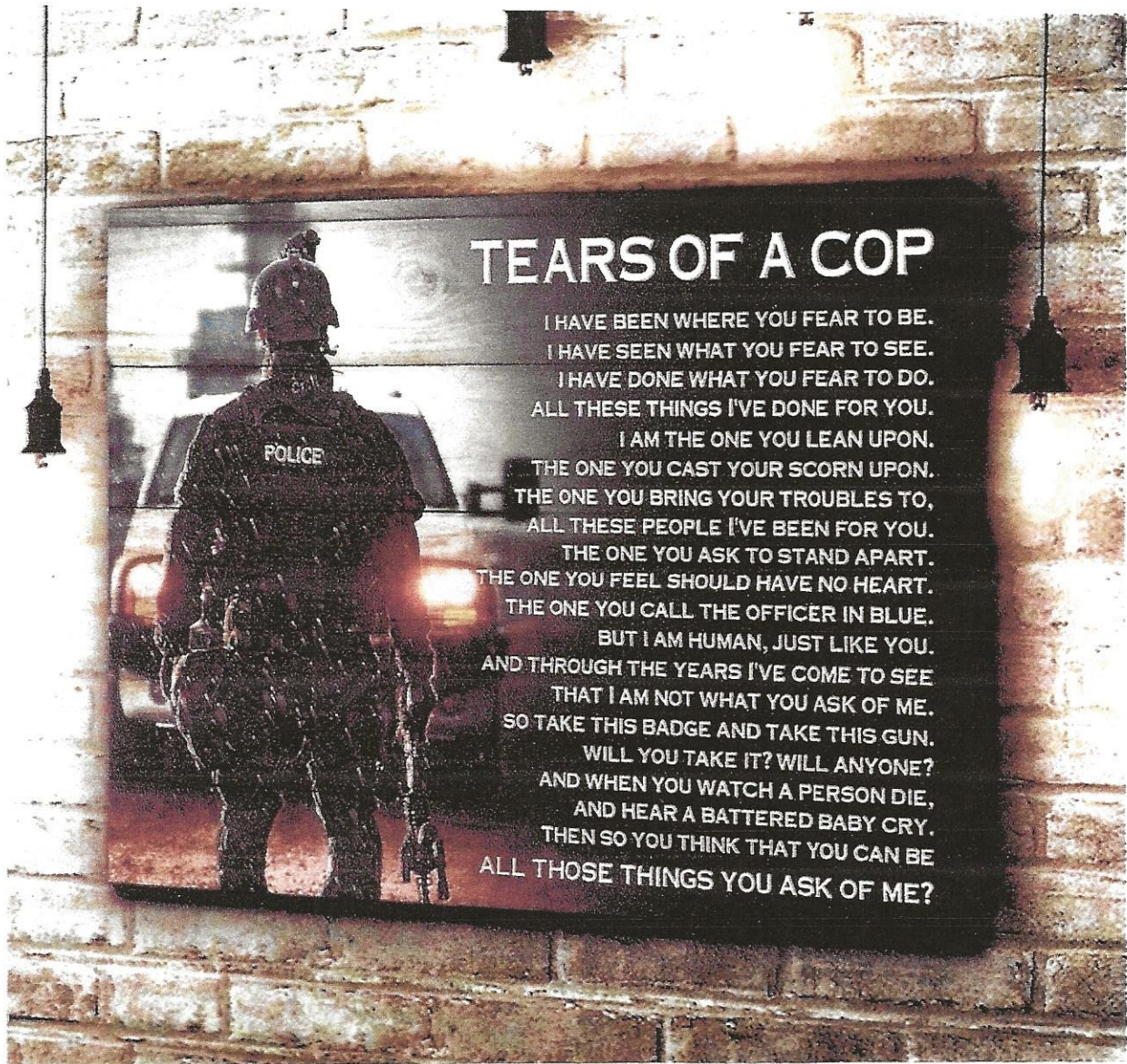
Notify companies the person did business with.

Cancel credit cards, and close charge accounts.

Tell airlines to transfer frequent-flier miles (in attendance with the will to the primary beneficiary).

Gather assets. This doesn't mean piling them all together. It means getting a list of all the assets at the time of the decedent's death, along with copies of statements, deeds, etc. This information is needed for probate. It's also essential for filing federal and state estate tax returns, if required. Review IRAs. If the surviving spouse is the beneficiary, decide whether to roll an IRA over to the surviving spouse. Get good advice—and get it now. The money you pay to attorneys and other advisers to resolve issues up front can be much lower than if you deal with problems after a person's death.

In case of couples, usually most of the property is held in joint names and the survivor obtains same "by operation of law". However, there may be some items which were held in the name of the deceased only, and in that case it would be necessary to go to Probate Court to transfer ownership of that property, unless listed in a trust. Consideration should also be given to making pre-death funeral arrangements. This provision, no matter how painful, should be discussed by couples and by parents with their families. Too often, spouse and children spend much too much money on a funeral and do so without really knowing what were the deceased's wishes in this regard (Place of burial, Cremation, etc.) Consideration should also be given to having a "Family Durable Power of Attorney" (Someone to take over your finances if you become incapacitated or incompetent) There are no words of comfort at such a difficult time, however if you have all the necessary information at the ready it will expedite any claim that is pending, make the process run smoothly and your stress level can be minimized.

Our goal is to encourage social, charitable, educational, benevolent, and fraternal activities among the membership. Our Club is actively involved, and has a good working relationship with, the Collier County Sheriff's Department and the Naples Police Department. Collier County 10-13 Club is also actively involved throughout the year in supporting causes such as children's diabetes or a Police Officer or first responder that needs assistance in paying medical bills.

Cancer Alliance of Naples (C.A.N)

Cancer Alliance of Naples was formed in 2002 with a group of volunteers to help our neighbors and friends through the most difficult times anyone can imagine. These volunteers saw a grave need in our community to offer assistance to cancer-stricken families and individuals whose lives were being turned upside down financially and emotionally and forced to make life changing medical decisions as well as dealing with mounting pressures of everyday living expenses. Cancer Alliance of Naples helps survivors, and their families pay rent, so family won't be evicted, pay utilities so they won't be turned off, pay for food for nourishment or car payments so they won't be repossessed. Our goal is to help families get on with their lives while they fight for theirs. Cancer Alliance of Naples is where patients throughout Collier and Lee County can feel welcome and support. Cancer Alliance is here to help when there is nowhere else to turn.

Collier County 100 Club

Collier County 100 Club was incorporated in 1985 and is part of an organization that has existed for many years throughout the country providing immediate financial support to the families of fallen officers. Over time the Collier County 100 club broadened their mission to include all first responders in Collier County to not only include the Collier County Sheriff's Office, but the various police and fire departments and emergency medical services, as well as the Florida Highway Patrol and the Florida Wildlife Officers serving Collier County. Besides their mission to providing immediate financial support to the families of falling first responders the club also financially assist first responders and their families in times of tragedy. This was to acknowledge the many financial burdens placed on first responders by tragedies other than line of duty deaths.

Common Sense Emergency Preparedness Tips:

- If possible, **move to a safe area** before the storm hits.
- Develop a **Family Plan** with your household members that outlines what to do, how to find each other, and how to communicate, evacuation routes, meeting point, etc.
- **Monitor weather conditions:** Stay alert to weather reports and conditions over a few days and pay attention to any instructions from local authorities.
- **Contacts:** Keep emergency contact numbers with you including family members, neighbors, friends, etc.
- **Secure important documents** especially those you may need to get through the emergency (insurance papers, account numbers, etc.)
- **Secure loose objects** in your yard, on your deck, roof, etc.
- Close and lock **windows and doors**.
- Tape & secure any **exposed glass surfaces**.
- Prepare a "**Go Bag**" that will contain necessary items without requiring time to gather them at the last minute.
- Keep on hand **non-perishable food** which can be eaten without cooking (canned foods, cereals, etc.)
- Keep an ample supply of **bottled drinking water**.
- Check flashlights or emergency lights that they are in working condition, and an **ample supply of functional batteries**.
- Keep a **battery operated radio** on hand.
- Keep **cell phones** charged and have handy a **car lighter adapter**.
- Fill your bathtub with **water for flushing** the toilet.
- **Gas up your car.** (If electrical power is off, service stations may not be able to operate pumps.) A car can serve as an emergency generator for lighting and charging some batteries – keep adaptors in the car.
- Prepare appropriate **emergency supplies** to sustain yourself and your family for a few days (recommended three day supplies) if the storm's path becomes more evident of impacting your area.
